Raj P. Soni

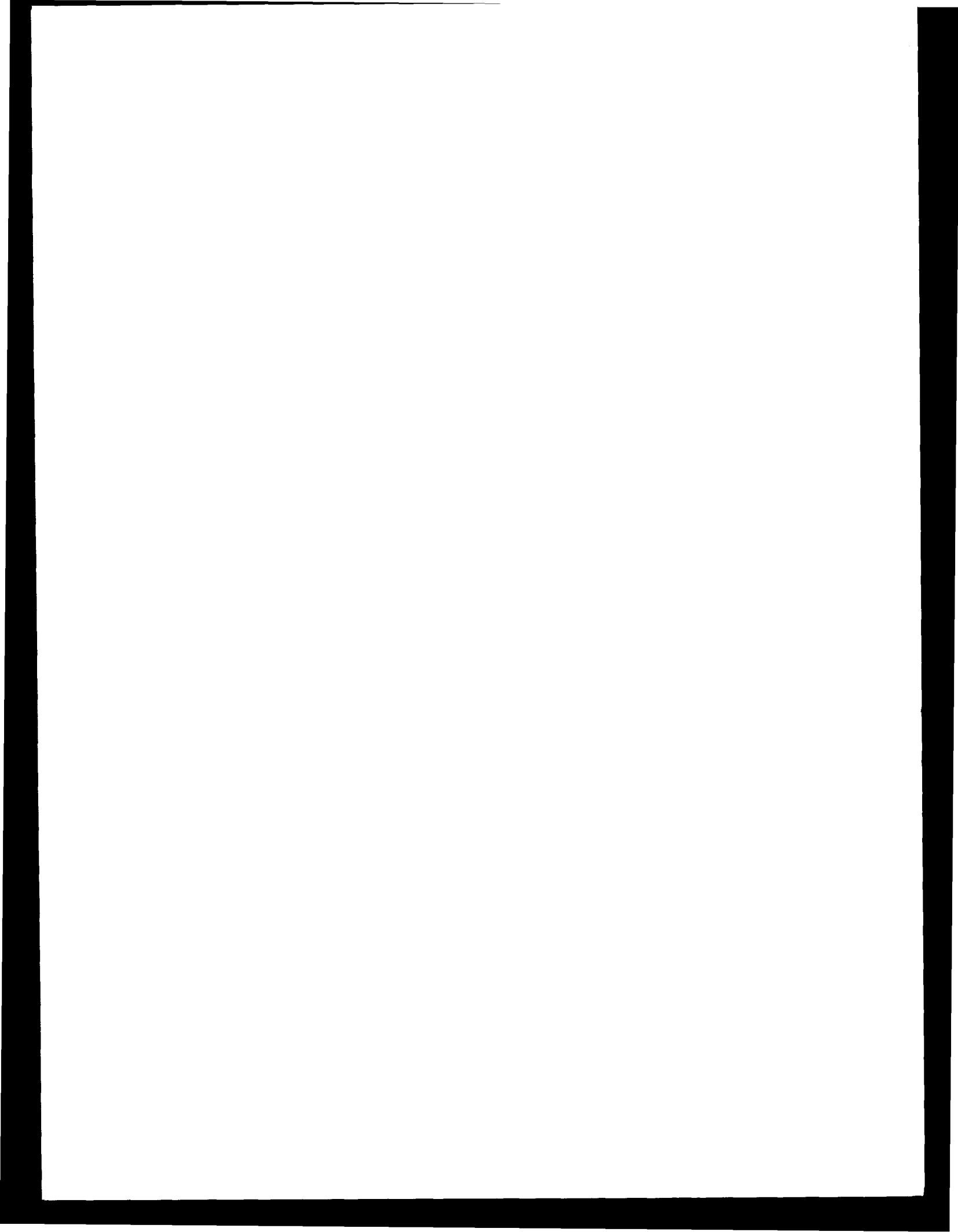
