

Compaq Thin Client 3-Year Limited Warranty Statement

Compaq warrants that the Compaq Thin Client product you have purchased from Compaq or from a Compaq authorized reseller is free from defects in materials or workmanship under normal use during the warranty period. The warranty period is three (3) years, and commences on the date of purchase. Your sales receipt, showing the date of purchase the Compaq Thin Client product, is your proof of the date of purchase. This warranty is not transferable to anyone who subsequently purchases the product from you. This Limited Warranty does not include expendable parts. With respect to Year 2000 compliance, coverage extends only to Compaq desktop and minitower PCs and a "defect" shall arise only if any such Hardware Product fails to pass the NSTL YMARK2000 test (Version 97.08.15).

Should the Compaq Thin Client product require service during the term of the Limited Warranty, Compaq will provide either mail-in or carry-in service (based on your geographical region). Compaq will repair or replace the defective product or part(s) with a new product or part(s), or at Compaq's option a serviceable used product or part(s) that meet or exceed the performance specifications for new products or parts. All exchanged parts and products replaced under this warranty will become the property of Compaq.

This Limited Warranty extends only to Compaq Thin Client products initially purchased from Compaq or from a Compaq authorized reseller. This Limited Warranty also does not extend to any Compaq Thin Client product that has been damaged or rendered defective (a) as a result of accident, misuse, or abuse; (b) as a result of an act of nature; (c) by operation outside the usage parameters stated in the product's user documentation; (d) by the use of parts not manufactured or sold by Compaq; (e) by modification of the product; or (f) as a result of service by anyone other than Compaq or a Compaq Authorized Service Provider. Compaq is not responsible for damage to or loss of any programs, data, or removable storage media.

EXCEPT AS EXPRESSLY SET FORTH IN THIS WARRANTY, COMPAQ MAKES NO OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. COMPAQ EXPRESSLY DISCLAIMS ALL WARRANTIES NOT STATED IN THIS LIMITED WARRANTY. ANY IMPLIED WARRANTIES THAT MAY BE IMPOSED BY LAW ARE LIMITED TO THE TERMS OF THIS EXPRESSED LIMITED WARRANTY.
